I-20 TRANSFER APPLICATION INFORMATION

In order to be eligible to transfer to Rennert you must:

1. Complete and sign all Rennert registration forms, including accommodation request, if any.
2. Pay in full for your course.
3. Present all the following documents:
 - Passport copy
 - F-1 visa copy
 - All previous and current I-20 forms
 - I-94 (electronic copy or original card)
 - Address in the U.S.
 - Address in home country
4. Present an official statement or letter from your bank showing that there are sufficient funds available to support yourself for the duration of study.
*Please note: The letter must be written in English and amounts must be shown in US Dollars. The letter must be dated *less than 3 months old*. If you are living in Rennert housing then you must show an additional \$1000 per month of study. If you are living in your own housing then you must show an additional \$2000 per month of study.
5. If you are *not* supporting yourself, you must present a letter from the bank of your family member or sponsor. The letter must be written in English and amounts must be shown in US Dollars. The letter must be dated less than 3 months old.
6. Ask your previous school's International Student Advisor to complete this transfer form and submit it to Rennert.
